### **Modified Abandonment – Crockanboy Road, Greencastle, County Tyrone**

The Department for Infrastructure (DfI) gives notice of its modified proposal to abandon an area of 8640 square metres of road at Crockanboy Road, Greencastle, Co. Tyrone extending from a point 300 metres north-west of its junction with Mullydoo Road for a distance of 1111.5 metres in a westerly direction, after completion of such works as the Department considers necessary for the provision for alternative facilities for road traffic.

The area of road proposed to be abandoned is delineated on a modified map which, together with a copy of a modified draft order, may be inspected free of charge during office hours within the period 17th March 2021 to 30th April 2021 at DfI Roads Western Division, Lands Section, County Hall, Drumragh Avenue, Omagh, BT79 7AF.

During the current Covid-19 restrictions, access to this building is limited and inspection of the draft Order and map is by appointment only which can be arranged either by email using [dfiroads.western@infrastructure-ni.gov.uk](mailto:dfiroads.western@infrastructure-ni.gov.uk) or by telephone during office hours (Monday to Friday 9.00 a.m. to 5.00 p.m.) on 0300 200 7899.

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) of the Roads (Northern Ireland) 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon an area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

The Department has modified the Draft Order.

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as The Crockanboy Road, Greencastle, County Tyrone (Abandonment) Order (Northern Ireland) 2021 and shall come into operation on 2021.

(2) In this Order “the Developer” means Dalradian Gold Limited whose registered office is situated at Killybrack Business Park, 3 Killybrack Road, Omagh, Co. Tyrone, BT79 7DG.

2. The Developer shall carry out such works as the Department considers necessary and on completion of the works the area of road described in the Schedule shall be abandoned.

## SCHEDULE

Article 2

### AREA OF ROAD TO BE ABANDONED

An area of 8640 square metres of road at Crockanboy Road, Greencastle, Co. Tyrone extending from a point 300 metres north-west of its junction with Mullydoo Road for a distance of 1111.5 metres in westerly direction more particularly delineated and shown hatched on Map No. IN1/21/50281.
