APPLICATION SUMMARY

Dalradian Gold Ltd applied for authorisation for two abstraction and impoundment (listed below) at the proposed Curraghinalt Mine, adjacent to 80 Mullydoo Road, Greencastle, County Tyrone, BT79 7QP (E258418, N383902)

- Abstraction of surface water and storage in the Clean Water Pond. (Application Reference AIL/2024/0003)
- Abstraction of Mine Water through dewatering of the underground mine and storage within the West Pond. (Application Reference AIL/2024/0004)

It is proposed that a maximum of 2250 m3/day will be diverted from the headwaters of the Pollanroe Burn, plus, as the underground mine is worked, a further 1650 m3/day of groundwater will be pumped.

A proportion of the abstracted water will be used for mine processes, on-site storage (clean water pond) as fire water and for managing the water table level in the underground mine.

ADVERTISEMENT ASSESSMENT

In line with the determination criteria, outlined in the AIL Advertising Operational Procedure DAERA Document AE1/22/542208 the following assessment has been made:

The proposal is a significant non-consumptive abstraction removing surface water and groundwater, to be returned to the environment via discharge on the Pollenroe Burn.

The site is located in close proximity to SAC, RAMSAR, ASSI and AONB, sensitive areas. Initial assessments highlight the potential risk of impact on sensitive designations.
