**DALRADIAN GOLD - PUBLIC LOCAL INQUIRY IN ACCORDANCE WITH THE WATER ABSTRACTION AND IMPOUNDMENT (LICENSING) REGULATIONS (NI) 2006.**

Thank you for your letter of the 9<sup>th</sup> July 2024.

Dalradian Gold withdrew the April 2024 abstraction and impoundment licence applications (AIL 2024 0003 and AIL 2024 0004) on 26<sup>th</sup> July 2024.

NIEA can confirm that on the 26<sup>th</sup> July 2024 Dalradian Gold submitted new abstraction and impoundment licence applications AIL 2024 0008 and AIL 2024 0009 for consideration. NIEA have processed these applications in line with the 2006 Regulations and internal procedures. A Notice directing the applicant to advertise these applications was issued, in accordance with Regulation 9, on 30<sup>th</sup> July 2024.

On completion of the 28 day advertisement period, NIEA will direct the Appeals Commission, in accordance with Regulation 17, to hold a public local inquiry to consider representations made. It is intended that this Direction will be made, along with the relevant paperwork, as soon as possible but no longer than 5 working days after the expiry of the advertising period.
