Many thanks for sending through the new notice under the AL Regulations in regards to proposals made by Dalriadan Gold as attached in your email dated 5 August 2024.

I have reviewed the applications and associated documentation as per the link below.

I am content that there is a very low risk of any impact on the sufficiency of supply at the NI Water abstraction point on the River Strule, located downstream of the abstraction at the Pollanroe Burn, and Owenreagh River.

However, it must be noted that the area under consideration for the development is within the drinking water catchment areas for a number of NI Water's Water Treatment Works (WTWs) and drinking water abstraction points. These drinking water catchments have been designated Drinking Water Protected Area (DWPA) under Article 7 of the Water Framework Directive. Any development carried out within a DWPA must demonstrate measures to ensure water quality and quantity are protected. Therefore, it is essential that robust measures are put in place to ensure that the quality and quantity of the raw water that we abstract is protected at all times to ensure that there is no risk to either the quality or sufficiency of the public drinking water supply.
